Summary of Safe Return to In-person Instruction



Continuing COVID Health Protocols Still in Place:

- Students and staff will be encouraged to continue frequent handwashing and sanitizing, to cover coughs and sneezes with a tissue, and to wear a mask.
- Campus staff will sanitize frequently touched areas and sanitizing wipes and/or spray will be available for use by staff as needed.
- Staff and students are encouraged to remain as physically distant from other persons as possible when on TBP campuses.
 Parents and other campus visitors will be limited to those who need to be on campus.
- A student or staff member who is presumed positive or tests positive for COVID-19 will be required to stay off campus until they have met return to work/school guidelines developed by the CDC.
- Close contacts of individuals who test positive for COVID-19 will be notified.
